Learning Objectives

Genomics is one of the most rapidly moving fields in modern science. It has an impact in all areas of biology and life science. The course has two broad areas of focus:

- 1. Bioinformatics
 - Approximately one third of the course is directed at introducing genomic databases and the software tools to compare sequence and infer evolutionary relationships. Four assignments during the term ensure that students become proficient at running various programs and interpreting the results. Web based software is used; no direct programing is involved.
- 2. Functional genomics
 - The other two thirds of the course focusses on assigning biological function to genes discovered through sequencing programs. The approaches include computer analysis, mutational analysis, gene and protein interaction, 3-D structure. The student will have an appreciation of the strengths and limitations of such methods as well as recognition of the current limits of experimental science. This portion of the course relies heavily on the current research literature.
